**CALL FOR EXPRESSION OF INTEREST FOR OPERATOR OF THE  
MOCUBA INDUSTRIAL FREE ZONE**

In the framework of establishing Economic Development Poles in the country, the government has approved the establishment of the Mocuba Industrial Free Zone of by Decree n°. 29/2014 of 06 June, covering an area of 50.58 hectares in the administrative post of Mocuba-Sede, District of Mocuba, Zambezia Province.

The Special Economic Zones Office (GAZEDA), the entity responsible for the promotion and coordination of all activities relating to the creation, development and management of Special Economic Zones, including the Industrial Free Zones, invites interested parties to express interest in the presentation of proposals for Operator of the Mocuba Industrial Free Zone.

To this end, interested parties should submit their proposals by letter addressed to the Special Economic Zones Office, and the same shall contain the following:

6. Demonstration of ability, experience and business or technical characterization of the bidders
7. Complementary Information
  - a. Website;
  - b. The financial report of the last five (05) years, where applicable;

- c. Bank references at origin;
- 8. CVs of shareholders and of members of the project management team;
- 9. Other relevant information.

### **Component 2: Investment Project**

- 1. Name/Name of the Project Implementing Company, registered in Mozambique;
- 2. Shareholding structure of the Project Implementing Company;
- 3. Volume of investment, development plan and funding sources;
- 4. Detailed plan of development of the IFZ of Mocuba;
- 5. Demonstration of the economic and financial viability of the project;
- 6. Statement of availability of financial resources required for project implementation;
- 7. Environmental aspects of the project;
- 8. Other relevant information.

### **Component 3: Social Responsibility Programme**

The bidder must present qualified and quantified social responsibility initiatives.

For better orientation in the development of proposals to be submitted to GAZEDA, interested parties should consult the Terms of Reference and Area Location Map of the Mocuba Industrial Free Trade Zone, available in GAZEDA and on its website ([www.gazeda.gov.mz](http://www.gazeda.gov.mz)).
